<p><b>Conditions Related to Reporting and Contacts:</b></p> <ul style="list-style-type: none"> <li>• Failure to call in at assigned date/time (1 time)</li> <li>• Failure to call in during office hours</li> <li>• Failure to inform Project Remand of address, telephone or employment change (1 time)</li> <li>• Failure to give accurate information to Project Remand</li> <li>• Failure to answer <i>any</i> calls from Project Remand</li> </ul> <p><b>Conditions Related to Treatment:</b></p> <ul style="list-style-type: none"> <li>• Failure to report on time for scheduled urinalysis or breathalyzer</li> <li>• Submitting a diluted drug test (1 time)</li> <li>• Failure to take medication as directed (1 time)</li> <li>• Failure to pass drug test (UA) or breathalyzer (BA) (1 time)</li> </ul> <p><b>Conditions Related to Potentially Criminal Behavior:</b></p> <ul style="list-style-type: none"> <li>• Failure to report police contact</li> <li>• New arrest not resulting in charges: traffic/non-alcohol related, driving: alcohol related</li> <li>• New arrest resulting in new charges: traffic/non-alcohol related</li> </ul>	<p><b>Conditions Related to Reporting and Contacts:</b></p> <ul style="list-style-type: none"> <li>• Failure to report in person for any reason</li> <li>• Leaving metro area without permission</li> <li>• Repeated failure to comply with any reporting and contact conditions (2-3 times)</li> <li>• Failure to surrender items</li> </ul> <p><b>Conditions Related to Treatment:</b></p> <ul style="list-style-type: none"> <li>• Failure to pass drug test (UA) or breathalyzer (BA) (2-3 times)</li> <li>• Failure to report for scheduled UA or BA (2-3 times)</li> <li>• Failure to schedule chemical health (CHA) or mental health assessment (within 2 weeks)</li> <li>• Failure to report for scheduled CHA or MH</li> <li>• Failure to comply with CHA or MH recommendations</li> <li>• Failure to pay alcohol monitoring fees</li> <li>• Untruthful about drug/alcohol use</li> <li>• Untruthful during CHA</li> <li>• Repeated failure to comply with any treatment condition (2-3 times)</li> <li>• Positive results on RADAR; admits or denies use (.02-.069 BAC)</li> <li>• Tampering with a drug test (1 time)</li> <li>• Submitting a diluted drug test (2 or more times)</li> <li>• Failure to take medication as directed (2-3 times)</li> </ul> <p><b>Conditions Related to Potentially Criminal Behavior:</b></p> <ul style="list-style-type: none"> <li>• New arrest resulting in new charges: nonviolent misdemeanor or traffic/alcohol related driving</li> <li>• Failure to comply with stay away order (non DV)</li> <li>• New arrest not resulting in charges: violent or nonviolent misdemeanor, gross misdemeanor, felony</li> <li>• Failure to report a new arrest</li> <li>• Non-threatening text reported by victim (no police report filed)</li> <li>• Defendant's phone number on caller ID reported by victim (no police report filed)</li> <li>• Sends non-threatening messages to victim through 3<sup>rd</sup> party (no police report filed)</li> </ul>	<p><b>Conditions Related to Reporting and Contacts:</b></p> <ul style="list-style-type: none"> <li>• Failure to report for scheduled court appearance</li> <li>• Repeated failure to comply with any reporting and contact conditions (more than 3 times)</li> <li>• Absconding</li> <li>• Failure to register address (for sex offenders)</li> </ul> <p><b>Conditions Related to Treatment:</b></p> <ul style="list-style-type: none"> <li>• Failure to remain in treatment</li> <li>• Repeated failure to comply with any treatment condition (more than 3 times)</li> <li>• Positive results on RADAR; admits or denies use (.07 and above BAC)</li> <li>• Tampering with a drug test (2 or more times)</li> <li>• Failure to take medication as directed (more than 3 times)</li> </ul> <p><b>Conditions Related to Potentially Criminal Behavior:</b></p> <ul style="list-style-type: none"> <li>• Failure to comply with no contact order (police report filed)</li> <li>• New arrest not resulting in charges: violation of protection/no contact order misdemeanor, gross misdemeanor, felony</li> <li>• New arrest resulting in new charges: violent or nonviolent misdemeanor, gross misdemeanor, felony; violation of protection/no contact order misdemeanor, gross misdemeanor, felony</li> <li>• Removal of electronic bracelet</li> <li>• Defendant called victim and made threatening comments (police report filed)</li> <li>• Defendant showed up at victim residence or work (police report filed)</li> <li>• Sends threatening messages to victim through 3<sup>rd</sup> party (police report filed)</li> </ul>
