STANDARD: No active supervision; PSO to respond to community or police complaints regarding misconduct. Defendant required to respond to any contact from PSO.

ENHANCED: Required to check in with PSO ≥ once per month + other conditions related to crimes.

INTENSIVE: Required to check in w/PSO ≥ 2 times per month and submit to random UAs, Curfews, SCRAM, GPS &/or other conditions imposed by the Court.

* Initial M11 security for up to charges is \$150K, + \$50K for each charge above 3. Court can reduce to minimum of \$50K (or less under extraordinary circumstances). ** Requires fact finding of commercial drug factors. NOTE: Where matrix says “+” security both required at jail, *but court can drop security requirements.*

**Conditions / Circumstances indicating possible flight or safety risk to the victim or public
REQUIRE SECURITY + CONDITIONS**

1. Statements from arrestee or others regarding intent to abscond;
2. Person is intoxicated or UI controlled substance (Except safe release to responsible 3rd party);
3. The person had made a credible threat (see below) to a victim, law enforcement officer or anyone else connected with the case;
4. Person otherwise appears unable to clearly understand or appears unwilling to follow conditions of release.

Jail Sgt or equivalent may contact a judge to authorize higher security pending court review.

**SPECIAL CONDITIONS OF RELEASE
(In addition to security where applicable)**

DUII:

1. Absolutely no consumption of alcohol;
2. No entry into liquor stores, taverns or bars.

Crime of domestic violence or other person crime:

1. Absolutely no contact with the victim, directly or indirectly;
2. No entry onto premises, business or other location occupied by the victim;
3. No possession of or access to firearms or other deadly weapons;
4. If alcohol is implicated in the crime, absolutely no consumption of alcohol.

Person Crime includes any ORS Chapter 163 crime, robbery, domestic harassment or attempt to commit such a crime.

Credible threat means more than “smart talk.” It includes a believable intent to act, and /or an opportunity or means to do so.
